





Demand for Hearing Services During and After WW II






Clinical Scholars Who Built the Foundation of Audiology Raymond Carthart, PhD "Father of Audiology"




Raymond Carhart (1912 - 1975)

- Developed clinical protocols while Captain in US Army
 - Diagnostic hearing assessment
 - Aural rehabilitation
- Established one of the first formal educational program for audiology at Northwestern University
- Research funding throughout his career
- Clinically applied auditory research
- Mentor to leaders in the first generation of audiologists
- My audiology grandfather

- □ At the end of the session, James Jerger proclaimed that we needed an organization "of, by, and for audiologists!"
- ☐ The room exploded with loud ovation and a riotous cheering
- Audiologists proudly and bravely declared their professional independence.

"Future of Audiology" Session 1987 ASHA Convention New Orleans Louisiana

- ☐ There was consensus at the conclusion of the session. We audiologists must ...
 - ✓ Become an autonomous profession
 - ✓ Evolve into a "doctoring" profession
 - Secure Limited License Practitioner status (patients do not need a physician referral to see an audiologist)
 - ✓ Develop an "enriched" educational curriculum (i.e., eliminate "Clinical Fellowship Year or CFY")
 - Achieve direct access by all patients
 - ✓ Create a professional organization for audiologists only
 - ✓ Develop a new professional governance structure

The Future of Audiology: A View from the United States of America Common Concerns (in USA)

- Educational of Audiologists
 - Total number of graduates of audiology programs is inadequate to meet demand for services (Windmill & Freeman, 2013)
 - ✓Annual graduation is not adequate to offset attrition and retirement
 - ✓ Growing demand for services with baby boomer population
 - Most audiology programs are within speech & hearing departments with a speech pathologist as chair.
 - ✓ Model is for speech pathology masters level education versus audiology with doctoral level education
 - ✓ Audiology students are drawn from CSD pool rather than pre-professional curricula like other health professions

The Future of Audiology: A View from the United States of America Common Concerns (in USA)

- Educational of Audiologists in the USA
 - Audiologists do not control accreditation body that sets standards for most university audiology programs
 - **✓**CAA (ASHA)
 - **✓**ACAE (AAA)
 - There are an excessive number of small graduate programs with inadequate
 - **✓** Faculty with expertise in critical areas
 - ✓ Clinical instruction and practicum opportunities
 - Business education courses are rarely offered, including courses on practice management

 - Time, energy, and money devoted to intra-professional skirmishes among:

 - **✓** ADA
 - **✓** ASHA
 - ✓ Hearing aid dealers
 - **✓** AAOHNS (otolaryngology)
 - Fragmented communication with major outside forces, e.g.,
 - √ Federal government
 - √ Hearing aid manufacturers

 - **✓** Comprehensive audiological assessment = ~\$30
 - Medical necessity requirement for reimbursement versus
 Limited License Practitioner model
 - Corporate
 - Ever changing coding, fee schedule, and reimbursement regulations and policies

- Focus on service not selling more widgets (hearing aids)
- Dangers of putting all hearing eggs in your basket
 - Hearing aid sales are not skyrocketing as we enter the baby boomer era. Why?
 - **✓** Consolidation of practices
 - ✓Internet hearing aid sales
 - **✓**Big box stores
 - **✓** OTC sales
 - **✓** PSAPs (personal sound amplification products)
 - ✓ New disruptive technology, e.g., smart phones with apps for self programming)
- □ Emphasize the "why" and the "how", not the "what"





The Future of Audiology: A View from the United States of America Bettie Borton, PhD (President of AAA)

- We need to decide who and what we are. What are our core principles and values?
- Currently we are fractionated and speaking with many uncoordinated voices.
- ☐ There must be a unified global network for audiology.

 Manufacturers are thinking and acting globally.
- We must define and maintain an appropriate and productive relationship with industry. We all serve patients and we all want to grow the clinical service market. We should work collaboratively and always tie the professional to the product.

The Future of Audiology: A View from the United States of America Devin McCaslin, PhD (AAA Board Member)

- Reimbursement continues to decline for staple diagnostic procedures
- □ Furthermore, generation of codes for new tests (e.g., video head impulse testing, canalith repositioning, VEMP) has stalled.
- □ Direct access is nice, but there won't be a profession left to access if we can't get paid.
- Soon hearing aids will be very cheap. They will be cool and linked to iPhones. They won't be called hearing aids anymore.
- □ Companies with smart people culled from Silicon Valley are emerging with low cost amplification systems that will be sold in pharmacies and big box stores.

The Future of Audiology: A View from the United States of America Devin McCaslin, PhD (continued)


- Pediatric vestibular assessment is an area of enormous opportunity. Audiologists need to embrace it.
- As audiologists we are charged with identifying and treating hearing loss in children. We should be diagnosing vestibular impairments as well, including in patients with Cls.
- The AuD killed our research based ... no research base means no profession. As editor of JAAA I see the quality of research declining.
- Audiology training is abysmal. Programs are slowly closing across the country as universities evaluate the value of audiology programs.
- Tele-practice is here and it is the real deal. You better have one of these programs or you will be left behind.

The Future of Audiology: A View from the United States of America Frank Musiek, PhD

- Diagnostic audiology has lost ground in general
 - Evoked potentials are not utilized by audiologists as they once were
 - Audiologists need to more concerned about the "health" of the auditory system and not just measuring thresholds
 - There is a lack of knowledge about disorders of the auditory-vestibular systems.
- Where diagnostics has gained
 - CAPD has gained visibility and demand
 - Research & education on CAPD is on the upswing
 - A number of MDs (neurologists) are interested in CAPD
 - More audiologists are becoming involved with CAPD

The Future of Audiology: A View from the United States of America Logical and Feasible Solutions to Common Concerns

- Education Reforms are Essential and a Top Priority
- Aggressively Market Audiologists as *THE* Hearing Experts
- □ Relation with Other Professional Organizations
 - Open and constant communicate
 - Tirelessly seek consensus on core issues
 - "Speak with one voice"

- Broaden Hearing Health Care Profession
 - Bring hearing aid dispensers into audiology fold
 - Support expansion of audiology assistants and technicians
- Return to Original Audiology Missions
 - Diagnosis of hearing loss and related disorders
 - Rehabilitation of hearing loss with optimal outcome


